Subject: Memorandum of Understanding

This Memorandum of Understanding (hereinafter referred to as "MOU") is entered into by and between Eter Srl Società Benefit, hereinafter referred to as "Party A," and The Museum of Osteopathic Medicine hereinafter referred to as "Party B."

This Memorandum of Understanding establishes the mutual conditions and obligations between the parties involved in order to promote and spread the history of osteopathy through Osteopedia.com.

Terms and Conditions:

1. Scope of Work:

1.1 Party B agrees to grant Party A the use of all other appropriate material to expand the section dedicated to the History of Osteopathy on Osteopedia.com, which is already rich in exclusive content aimed at enabling maximum spreading of the basic principles of osteopathy.

1.2 Party A is committed to spreading the History of Osteopathy comprehensively, through its website Osteopedia.com, with the aim of reaching the widest possible audience nationally and internationally.

2. Roles and Responsibilities:

2.1 Party A will use the material granted by Party B exclusively for the creation and enrichment of the section 'History of Osteopathy' of its website Osteopedia.com.

2.2 Party A will acknowledge all the material granted by Party B for the website Osteopedia.com always crediting the source in the format preferred by Party B.

3. Duration:

3.1 The MOU will be effective from the date of signature by the Parties' authorized representatives and does not have an expiry date. Nevertheless, either party may terminate it at any time with a minimum 30-day written notice.

4. Resources:

4.1 Party B resources are all copyrighted historical materials, including but not limited to pictures, books and documents owned by Party B.

4.1 Party A resource is its website Osteopedia.com.
